According the Dutch Government an International Arrest Warrant would have been issued by the Republic of Turkey on 17.12.1995 resulting in an arrest in the Netherlands on 24.12.1995. Apparently this document (currently) doesn't exist or can't be found/produced by the Dutch Government. Therefore both I and the concerning person himself (see attached power of attorney) do ask you for any information available on this topic.
